**Resolution:** Minutes were agreed as a true record subject to an amendment to item 105 to read Cllr Carlson as proposing not Cllr Cole. All in favour.

**ACTION:** Defer the following to January F&GP agenda: - review of the Code of Conduct, update on Leisure Centre and review of HR policies.

The Clerk has received in writing our insurer's confirmation that the fidelity guarantee insurance is covered within the Commercial Crime section. All grant applications have been paid. GWW have been advised. The RFO has agreed a three-year deal for the electric at Croft Field and our maintenance man is in touch with the Men's Shed about a sub meter for their usage. We are waiting for a date for the library roof survey.

This would be subject to conditions such as the signing of a hire agreement, including having necessary insurance and health and safety procedures in place. No driving on the field would be permitted. Lighting only to be provided and any racking would be approved or fitted by Cllr Keates.
