# **Update on actions:**

- Omega Signs signage had been replaced with new prior to planning permission.
   Feedback now received from the case officer: "The council do not encourage owners to construct signage without consent if they do so it is at their own risk and face the possibility of having to replace the signage".
- Case officer report ref planning app 21/02667/COMIND HTC had objected on the grounds that clarification of the site boundary was required as it was different to that of the 2019 application. Feedback now received from the case officer: "Ownership details were submitted to the planning registration team and they were satisfied with this and the submitted certificates. The red line does not show ownership but instead indicates the land required for the development."
