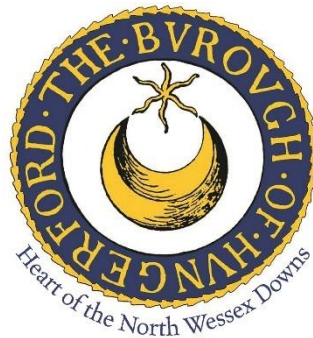

7 Charnham Street – Mr J Scott and Mrs Scott

Proposed First Floor Rear Extension & Associated Internal Alterations.

Proposed: Cllr Keates

Seconded: Cllr Greenwell

Resolution: No objections. One abstention.

Cllr Yakar-Wells entered.

b) 22/01847/HOUSE

34 Kennedy Meadow – Mr & Mrs Lewis

Ground floor rear extension to create new kitchen/family/dining space following demolition of existing conservatory. Part garage conversion.

Proposed: Cllr Simpson

Seconded: Cllr Carlson

Resolution: No objections.

c) 22/01893/HOUSE

Adjacent Parish: White Gates, Hungerford Park – Mr and Mrs Mike Smith

Single storey to the side of the building. Mansard roof extension to the rear of the building

Already refused by West Berks Council

d) 22/02034/HOUSE

17 Macklin Close – Mr and Mrs A Miller

Proposed conversion of garage and single storey front and side extension

Proposed: Cllr Winser

Seconded: Cllr Lewis

Resolution: No objections.

e) 22/02036/HOUSE and 22/02037/LBC2

39 High Street – Mrs Imogene Knight

Proposed internal alterations comprising the removal of ground floor internal wall; opening up of existing ceiling to create vaulted space; formation of French doors to west elevation; and installation of 3 no. roof lights. Erection of new stud walls to first floor to allow for the creation of a shower room and boiler cupboard. External changes include the replacement of windows to the north-elevation to match existing and adjustment of sill heights. Block up existing door opening to north elevation. Demolition of existing garden store, and erection of new timber canopy.

St John's Hall, Station Road

Demolition of Derelict Building (Former Ambulance Station and redevelopment for 10 flats with basement parking and landscaping cycle parking and bin stores

Resolution: Object. One abstention.

Reasons:

Current parking does not meet West Berks Council's own requirement for the building.

No recycling facilities.

Bin location is in the path of cars entering and leaving the site.

No clear statement on how many affordable units will be provided.

Access Land To Chilton Foliat Sewage Treatment Works Hungerford - Thames Water

Replace/upgrade existing pumps, break into existing rising main at or near the existing access road into Chilton Foliat and install rising main, washout chambers and remove/seal off the consented discharge outlets.

Resolution: No objections.

9 Downview – Oliver and Ashlee Fraser

Single storey rear extension and associated works

15 Bridge Street – Tania Hunwick

15 Bridge Street was originally divided into a flat and a shop. In 2006 a wing was separated in the flat to create a separate apartment.

Resolution: Object.

Reasons:

Grave concerns with regards to the breach of listing. No current up to date plans and no previous plans. Until such time as they are provided to West Berks Council we object and in addition evidence of both flats being occupied for 100% of the time is required.

Dick Lovett Mini Hungerford Garage – Pier Architecture

Demolition of outbuildings and pub rear extension and extension and redevelopment of existing MINI dealership incorporating adjacent property

Reasons:

Thrilled to see a large local business remaining and investing in our town.

Stubwood House – Mr and Mrs Benton

Conversion of existing garage to form home office and bedroom above with enclosed walkway to the main house. Proposed timber garden store to rear garden. Proposed swim pond to rear garden.

Resolution: No objections. One abstention.

l) 22/02246/HOUSE

22 Aldbourne Close – Ms A Power

Proposed single storey extension

Proposed: Cllr Yakar-Wells

Resolution: Object.

Reasons:

There is still insufficient parking to the size of the property, and we would be interested to see planning permission and building regulations for conversion of the garage.
