Agenda Item No: FGP20220092 Consider quote for repair/replacement of lampposts

Background

There are 4 streetlights owned by HTC in Upper Eddington. One was replaced with an LED lantern a year or two ago, and there are three that need replacing.

We have received complaints from the public that one is not working and all three are in a bad state of repair. See image below. (This item missed the last H&T agenda and now requires a more urgent response).

Objective

Upgrade all to LED. Ideally WBC would adopt the lampposts once upgraded. Unfortunately, with these four a spacing issue means that WBC could not achieve highway standards without significant expenditure and a number of additional columns, which would not really be suitable on what is a quiet country road.

Options

- a) Replace the 3 lanterns only, costing approximately £300 per lantern (£900 total),
- b) Replace the 3 lanterns, the brackets and transfer boxes also, costing approximately £750 per streetlight (£2,250 total). As unfortunately to change brackets WBC has to pay SSE about £300 to disconnect and reconnect to their cables.

Available Funds Earmarked reserves £39,749.35

Recommendation(s)

Option B is recommended by WBC as they were all marked in poor condition following their last inspection and it would be a good idea to replace the brackets and transfer boxes at the same time.
