**DRAFT MINUTES** of the **Full Council Meeting** held on Monday 6<sup>th</sup> June 2022 at 7.00pm in the Library, Hungerford

**Present:** Cllrs Simpson, Chicken, Fyfe, Downe, Alford, Shatford, Knight, Carlson, Schlanker, Yakar-Wells, Keates and Greenwell

Also: West Berkshire Council (WBC) Emily Ashton-Jelley and Meghan Dalgarno, District Cllrs James Cole (JC), Dennis Benneyworth (DB) and Claire Rowles (CR)

Representatives from Penny Post, Newbury News and Notrees Care home.

In attendance: Claire Barnes (Town Clerk) and several members of public.

Police Report: The police were not in attendance and no report has been received to date.

West Berkshire Council presentation on their Environment Strategy and Delivery Plan: (Please refer to the attached power point). Particular points of interest and questions raised are summarised below. Hungerford schools are encouraged to become part of the eco-school's education programme. WBC can help with this and part fund it. The school will become accredited as a result.

Additional restrictions grant for businesses has now closed.' Dine out sustainability' is the new promotion with a deadline for applications of 27<sup>th</sup> June. The next digital magazine is coming out in the summer. The Hub has applied so will be featured in the promotion. The Veolia sustainability fund is available for projects enhancing biodiversity and recycling etc. The deadline for this is 4<sup>th</sup> November.

The Greening Campaign is underway and WBC fund 50% of the fees. Parishes are being asked to be the lead for their area. Kintbury PC are active on this and it was suggested Hungerford may wish to partner with them.

If anyone wishes to join the WBC Climate Forum they are welcome to be added to the mailing list for the 6 weekly meetings. Cllr Downe has been attending these. If we wish to highlight a particular project to the community it can be included in the Resident's magazine.

Cutting has been reduced to twice a year and no mow May is being observed. Verges are being left uncut where possible and safe to do so. Every tree with Ash die-back will be replaced. WBC are working with Greenham Trust on their 25,000 tree planting project and if there are any pieces of land appropriate to plant on please can we let them know.

It was asked why there is not a focus on planning to become more sustainable following the declaration of a WBC Climate Emergency. Emily advised the Local Plan Review is on-going and they are consultees. High standards set can be overruled by appeal. They are working with BBOWT for advice on rewilding and a tree maintenance policy is in place.

More info was requested from WBC on the fuel poverty grant and how the 120/130 people will be selected.

Zoe Williams, manager of the care home spoke<br/>representing all the staff and the majority of the residents at Notrees, wishing to increase<br/>awareness of the proposed closure. They are putting together a counter proposal. Kintbury<br/>PC has already made representations.

She advised there has been an increase in respite care so they wish to offer more interim placements for patients coming out of hospital ahead of them returning home. They have received recent referrals from hospitals. Occupancy has remained low due to Covid. The needs of those in care have increased so they weren't able to take admissions and now when they are in a position to improve this, they are faced with closure. Notrees are locally staffed, and they have had no trouble recruiting, apart from obtaining temporary staff. They currently have 10 residents at Notrees but have capacity for 16 permanent residents and 2 respite. More staff have recently been employed to provide a safe environment. Notrees is 40 years old but has recently been refurbished. It is in a relatively rural location and the only residential setting in WBC. It is set to close within the coming 18 months and it is not clear what the plans are for the building.

- ACTION: Councillors will individually respond to the consultation and District Cllrs will provide more information along with a copy of Kintbury PC's response.
- **FC202200135** Receive Mayor's Report <u>See attached.</u> Constable Peter Joseph was present to invite all councillors and staff to a social meeting at the Town Hall on 22<sup>nd</sup> July to help build a stronger relationship. His invite was welcomed by the Mayor.
- FC202200136 Receive District Councillor's Reports – HTC was congratulated on the success of the Jubilee celebrations. A retaining wall found when foliage was cleared near the Priory Road roundabout will be fenced off and made safe. It was thought to be an old bus stop and will be replaced with a smaller wall. Cllr Fyfe was thanked for his PROW report and works in respect of this will happen in the winter. A Member's Bid has been submitted for the wildflower matting. WBC failed to find a consultant for the conservation area appraisals and the money is no longer available. Instead, it will be project managed in house. The out of hours 'customer journey' service has worked well and will continue to run. Reported footway defects around town are scheduled to be repaired. The abandoned vehicle in The Croft has been removed. A thanks was extended to all involved in keeping Hungerford clear of litter during the Jubilee celebrations. DC Rowles is lobbying our MP to improve safety at the Denford junction. The foliage is being cut back but speeding is an issue as too are the heavy vehicles driving through Denford. DC Rowles is also addressing areas that feel unsafe due to poor lighting such as the alleyway past the Fairfield allotments. It was reported that Jon Winstanley is arranging for the 12 listed milestones to be painted.

**FC202200137 Consider request from WBC for list of any local issues in relation to water abstraction, storage, mains supply, sewer system and wastewater treatment, to assist with their future investment plans.** DC Cole advised this was his request as they will soon have the opportunity to put forward questions to Thames Water. The deadline for responses is 30<sup>th</sup> June. A couple of concerns were raised such as the impact due to population growth and neighbouring parish projects affecting Hungerford. Any feedback should be directed to DC Cole.

FC202200138	Health & Safety – Any complaints or concerns, (including Denford Junction and footways in Coldharbour Road) – The Mayor reported that every resident in Coldharbour Rd and Clarkes Gardens had received a letter from WBC recognising the poor footway workmanship and advising that necessary remedial works will be made. Lessons have been learnt and in future inspections ideally should take place before, during and after works.





- The Greening Campaign provides tailored action plans for each
   Parish to help kick-start climate action and adaptation in your area
- □ There are 4 phases to the campaign:
  - Phase 1 community engagement
  - Phase 2 acting together: retrofitting, re-wilding and human health
  - Phase 3 self assessing the community in light of sustainability
  - Phase 4 adaptation
- □ Each phase costs £50 WBC will part-fund 50% of fees for Parishes
- □ Parishes are being asked to be the lead for the Greening Campaign for their area
- □ Kintbury, Beenham, Stratfield Mortimer, and Ufton Nervet/Sulhamstead have signed up
