MINUTES of the Full Council Meeting held on Monday 5th December 2022 at 7.00pm in the Library, Hungerford

Present: Cllrs Simpson, Fyfe, Winser, Alford, Carlson, Keates, Greenwell, Schlanker, Yakar-Wells, Knight, Downe and Hudson.

Also: West Berks District Cllrs James Cole (JC), Dennis Benneyworth (DB)

Representatives from Penny Post, Newbury News and James Wilcox (Age Concern)

In attendance: Claire Barnes (Town Clerk), Tim Williams, Marcus Barton, Lee Sainsbury and a member of public

Police Report: The police were not in attendance. It was noted there have been no further problems at the allotments with thefts and damage, however Lambourn has been targeted. A white van carried out a hit and run and was left burnt out in North Standen Road. Garages in Hungerford have been broken into. We hope to receive more info on these two incidents in due course. (a **Police report has since been received which is attached**)

Presentation of Mayor's award: The Mayor expressed her thanks to Tim Williams and Marcus Barton for their continued contribution to the town. Every year on Remembrance Sunday they fly a Tiger Moth over the town making the parade that extra bit special. The Mayor also expressed her thanks to Lee Sainsbury who has been a volunteer photographer at many of the town events for the last few years providing a range of images for free. The Mayor presented them all with a certificate and coin as a token of her appreciation.

James Wilcox: Age Concern has run Fairclose in Newbury for the past 55 years providing over 60s with hot food. They provided 450 meals on wheels this week. They have been supporting Redwood House in Hungerford delivering food for the last 3 weeks and feeding 20 to 30 people a day. The restaurant is open 4 days a week Mon-Thurs from 11.30am to 1.30pm. The Redwood offering is available for people not living in Hungerford but they do require pre-booking. The meals cost £7 and include two courses and tea or coffee. In order to keep to this price, the service is manned mostly by volunteers, and this is an appeal for more volunteers. They carry out DBS checks and train all volunteers to pass a level 1 in hygiene. Another project being pursued is the development of a dementia hub for all of West Berks.

ACTION: The office is happy to help promote both the service and request for volunteers.

A member of public addressed Town Council following up on his question at the last Full Council meeting as to why there is no borough policy to prevent people parking on footways and no priority stated for pedestrians. He asked if HTC would put pressure on West Berks Council (WBC) to take some action. He added that a document in existence was written in 2008 and is totally out of date. Councillors expressed their support and concern and added that cars are also being parked on grass verges and footways are being damaged. The member of public was invited to attend the next Highways and Transport (H&T) Committee meeting. Cllr Hudson suggested it was worth compiling an inventory of when and where this problem is happening.

ACTION: Cllr Downe and the Mayor requested an urgent response from a senior member at WBC on the progress of the EV chargers as we have been waiting 18 months for these to be installed. It was again suggested that another location such as Church St Car Park could be a solution if the wayleave issue cannot be resolved for the Station Car Park.

FC202200225 Receive Mayor's Report – See attached. The Mayor added that the Christmas Lights at Clarke's Gardens look spectacular and are in aid of the Air Ambulance. She wishes to thank the residents and encouraged all to visit and support the cause.

> The Mayor wished to bring to everyone's attention the circumstances of WBC's meeting which took place on 1st Dec and is available to view on-line. DC Rowles had asked to be removed from the WAP committee due to an outstanding conflict of interest query. She was told she could not cherry pick and was removed from all six of the committees she stood on by the Leader of the Council. The Mayor thinks the treatment of DC Rowles is shocking and appalling. DC Cole added that his future as a DC is in considerable doubt as he can't abide by this bullying behaviour.

FC202200226 Receive District Councillor's Reports – JC advised there have been 1135 signatures on Maris Dobson's petition against the charge of £24k made for not competing a CIL form. He encouraged engagement with the Local Plan Consultation which is live. There will not be a free for all for contractors to submit planning applications as parishes will have a couple of years to finalise their NDPs. A new exec Claire Lawrence will be joining WBC on 6th March, and she will be involved with the Local Plan and town centre masterplans.

ACTION: Circulate the link to the town strategy consultation which is now live.

JC advised there have been 95 enquiries through the cost of living hub, the deadline for community champion applications is 2nd January and the deadline for the sustainable warmth grant is the end of December. Cllr Downe is in touch with Adrian Slaughter for further details on the grant and how this is being promoted as the work has to be done by the end of March. JC is pursuing an answer about the drainage issues on the high street.

ACTION: Cllr Schlanker and JC will arrange to attend a survey with WBC and the resident about the flooding problems.

FC202200227 Health & Safety – Any complaints or concerns. The Mayor advised the improvement work to the footway outside Coffee1 had been completed and work on Cold Harbour Road verges has started. The Mayor wished to feedback to WBC that she and Cllr Fyfe had a very positive meeting with Nick Coulson about the planned footway improvements. The high kerb and bad condition of the parking bay near Fairfield allotment has been reported and may be considered if there are funds available.

FC202200231 Consider environmental aims and objectives for inclusion in the Action Plan

Cllr Downe advised he wished to obtain councillor's views to formulate a policy. A presentation had been circulated (see attached) based on figures obtained from Exeter Uni, Centre for Sustainable Energy and the BEIS impact study. The carbon footprints for Hungerford are based on four areas. The first two (housing and travel) are what HTC would most likely be most involved with, but we might wish to think about other areas such as recycling, allotments, repair cafes etc. Do we wish to focus on HTC's direct carbon footprint or the other extreme, influencing the whole town?

Various points were discussed such as the desire to go paperless, the impact of the cows on the Common, the lack of locally skilled plumbers and heating engineers that have a vested interest in Heat Pumps, and the wish to impact on the standard of new builds. It was noted that the building standards have improved from last year. As the planning process is government led could further improvements be achieved through pressure on WBC and working together with other parishes? It was suggested HTC should lead by example and work together with WBC, HEAT and local heating engineers to encourage clean energy such as ASHPs, turbines and solar.

ACTION: Cllrs Downe and Greenwell would be delighted to receive feedback from councillors on what HTC should be doing to limit its direct carbon impact. Responses are required by the end of December for discussion at next Full Council.

HTC POLICE REPORT December 2022

This is our favourite time of the year. Although a busy few months for the team we always look forward to the annual Christmas Light Switch on, which again this year did not disappoint. It was great to see soo many local people in attendance. We were also very lucky with the weather. We also attended the Remembrance Sunday event; laying a wreath in remembrance of all those who lost their lives in conflict.

Since the start of November there has not been a single reported incident of anti-social behaviour in the town. We sometimes find that news travels fast round a community particularly on social media - but if no one officially reports to Police, we don't know about it.

I have been made aware that the Big Issue seller that is usually in the High Street outside Coffee#1 has been abusive and insulting to members of the public when they pass by or decline to purchase a copy. I have also received concerns that his ID is fake and he is not a legitimate seller. I have checked his ID and made enquiries with the Big Issue who are disappointed by reports of his conduct and they have escalated the matter to deal. I can also confirm that his is a legitimate seller and his ID is not fake.

During the middle of November we saw a spate in theft reports and Criminal damage to the allotments at Marsh Lane. Work has been done to better secure the location and tool marking was offered to allotment holders. There have been no recent reports.

On the evening of the 2nd December there was a report of a Road Traffic Collison on the junction of the A338 and Atherton Road. One vehicle involved in this incident left the scene and was later found burnt out in Wiltshire Police area just past North Standon. Our roads policing colleagues attended the incident and an investigation is currently ongoing.

The Team

The current set up of the Hungerford and Downlands Neighbourhood Police Team is 1 x Inspector, 1 x Sergeant, 2 x Police Constables and 5 x Police Community Support Officers. The team are contactable by email but this should not be used in an emergency or for reporting crime as it is not monitored 24/7. It was suggested that Town Cllr's will be offered the same training as ward members, in planning which will hopefully help support planning knowledge at parish/town council level.

Town Strategy Meeting

Again, this first meeting was well attended with good representation from the community. Working in groups, everyone contributed to aspirations for improving the town, as and when funding opportunities become available. The next meeting will be held in January.

Youth & Community Centre 10year anniversary

- 1. A representation of residents from Sandham Green attended the meeting to raise their concerns about speeding through the hamlet. We agreed that we would support them in their efforts to introduce a 30mph limit.
- 2. WBH have agreed to extend the footpath into the croft with a date for the work to start be confirmed
- 3. A review of the data collected by the SIP devices showed that the majority of the traffic was staying within the 30mph although a significant minority are speeding. Further data is being collected and new locations for the devices being agreed.


