**Background** HTC appointed an arboriculturist to produce a report on the condition of the trees at St Saviours and identify any works required. This was particularly due to the amount of ash trees at the cemetery some of which are showing signs of ash die back and some are roadside.

**Objective** Appoint a tree surgeon to carry out the necessary works identified by the arboriculturist. Includes removal of 6 trees and trimming back of others.

Reference to Action Plan Aim – Ensure public open spaces are well maintained

**Available budget (£s) including cost centre -** Earmarked reserves £7221.27. Note we may need to access contingency budget for any unforeseen tree work required over the winter. The lime trees in the Churchyard will need pollarding later this year (cost £850) which will fall within the remaining funds.

**Health & Safety and Legal implications –** Some ash trees have extensive ash die back. Several are adjacent to the road. Branches from roadside trees are currently impeding high sided vehicles and pruning has therefore been specified. This will require traffic management.

**Other information** A tree planting plan will follow.

**Agenda Item No EFC20220011:** Propose acceptance of recommendation from R&A to appoint Vita Play

**Background** ROSPA continues to identify trip hazards on the safety surfaces at both play parks. There are more in need of attention at Bulpit Play Park in particular. Vita Play carried out a site visit and have provided quotations. R&A recommended repair however on requesting confirmation of warranty details Vita Play have confirmed they can only offer a 1-year guarantee on over skims. I have therefore obtained an alternative quotation for full removal of the existing rubber and reinstatement of the groundworks to obtain a 5-year warranty. The second quote includes the surface for the new seesaw.

**Objective** Address shrinkage and trip hazard issues in the existing safety surfaces. Improvements will involve rolling the surfaces into the grass which will avoid shrinkage occurring at the edges.

Reference to Action Plan Aim – Ensure public open spaces are well maintained

# **Options (including quotation)**

- 1) Overskim of 5 safety surfaces at Bulpit Lane Play Park Basket swing, Cradle swing, Spica, Sensory Orb and Balance Pads. 1-year warranty. £6,493.81 plus VAT
- 2) Supply and installation of 6 new surfaces. Removal and safe disposal of existing rubber safety surfacing including reinstatement of MOT type 1 groundworks Basket swing, Cradle swing, Spica, Sensory Orb, Balance Pads and Seesaw (cheaper than GB Sport & Leisure who are quoting £3207 for one surface). 5-year warranty. £10,619.66 plus vat

**Available budget (£s) including cost centre -** £9,636 Earmarked reserves. Funding to be addressed in item EFC20220016 later in the agenda.

**Health & Safety and Legal implications** Trip hazard. Risk level low.

#### Other information

We used Vita Play in Nov 2020 to skim 3 surfaces, and these are still okay however we did some repairs previously to edging through another company and that failed quickly.

#### Recommendation(s)

The best option, based on the above information.

### **Background:**

The attached spreadsheet shows a comparison of quotes received for supply of

- a) The small trees (1.25m) for the High Street and Bridge Street total required 193, to be mounted in holders or on blocks on ledges.
- b) Larger trees: 1 x 22ft for The Wharf, 1 x 30ft for outside the Town Hall, 2 x 10ft and 1 x 8ft tree for the Town Hall balcony.

In recent years the small trees have been supplied by Jadecliffe, from East Woodhay but we have normally had to go further afield for the large trees, which are usually installed by the supplier. Last year Jadecliffe did supply our large trees, after our intended supplier pulled out at very short notice, when it transpired they were unable to comply with our requirement for a RAMS in relation to the installation of the trees. Jadecliffe were able to provide the large trees but were not able to install them. This meant that we had to engage a local contractor with suitable equipment to move the trees into position, but that a Council employee had to secure the trees as the contractor was not insured to do so. This year all the prices have increased but the cost of the large trees has risen particularly steeply.

Jadecliffe's price for the small trees is £2,291.10 delivered, as against the 2021 cost of £2,159.70 (increase of less than 6%).

Eleveden's quote for the largest trees is the lowest and is also the only one to include installation. However, their price, at £4,520 delivered and installed is £1,372 higher than last year's cost (for purchase and installation the large trees only). They have, at our request, quoted for the supply of a 25ft tree, rather than 30ft, which would reduce their total price to £4,045 (a saving of £475.00).

There is an additional charge (estimated) £450.00 for casual labour, to trim the small trees to fit into wall brackets

# c) **Objectives**

To source suitable trees and install them in order to maintain the standard of the town's Christmas lights display. To consider the additional costs involved owing to general inflation and in particular transport costs.

**Reference to Action Plan:** Annual event to bring Christmas spirit and increase visitor numbers
