R&A 16th Jan 2023 – UPDATES from Town Clerk

RA2023004 - Receive updated summary of maintenance list

Some of the main works completed by our maintenance man are as follows: (Please note he took some leave over the Christmas period).

- Filled grit bins
- Fixed door handle at swimming pool house
- Fixed leak to roof at swimming pool house
- In process of fixing broken bench by Great Grooms (wood on order)
- Checked wobbly bollard at Bridge Street WM. It isn't unsafe but he will secure.
- He is halfway through installing a latch on Bulpit Play Park gate

RA2023005 - Receive update on ROSPA

A report was carried out on 19th Dec 2022. It is looking much better now that the safety surfaces have been replaced at Bulpit Play Park and are no longer on the report. There are three surfaces at Smitham Bridge which we could look at doing in due course. Other than items to monitor such as chain wear, some comments about caps missing and some parts that could do with painting there are few actions identified. Three medium risks which I have drawn to RB's attention are as follows:

- Smitham Bridge Play Park. Gate (the one to the bridge) has a violent action
- Smitham Bridge Play Park. Slide edge to be chamfered
- Bulpit Play Park. Carousel Waltz Top cap needs tightening



These are specified on his maintenance list to be completed.

RA2023007 - Receive update on Marsh Lane allotments

The below was the situation at last R&A in Nov 2022. To date we have received no further update from Mark Norgate.

The allotment lease currently expires on 31st December 2022. The letter written to the landowner on 18th Oct stated, 'If we do not hear from you by the end of October, we will assume that it is acceptable for the allotment holders to tend their plots and prepare them for another year's cultivation.' In response to a follow up letter on 7th Nov MN replied he had spoken to Mr Clothier recently and said he'd reply on his behalf. MN said he is somewhat snowed under at the present time, so apologies that he hasn't got round to doing so yet, it is on his list.

Reference a possible future allotment site at Triangle Field, I have enquired with WBC about possible vehicle access from the end of the field directly onto Inkpen Road. I wait to hear back.

RA2023010 - Croft Field Activity Centre

Mark at Abacus says he is looking at an early-mid February start for the Croft Field building works. Carl (project manager) is chasing him for an exact date.

RA2023011 - Skate Park

We are awaiting tweaks to the final design incorporating better seating and addressing any valid comments received in the consultation. An example contract has been received. See attached.

Health and Safety reports for Hungerford War memorials (x2)

Cllr Jerry Keates 6th December 2022

Main town War memorial

Overall appearance - memorial area presents as being well cared.

Memorial- would benefit from cleaning of the steps and canopy above the name plates.

This would also keep the plate areas clean for longer.

Benches (x5) - are safe to use but a couple are looking tired especially the 2 on the northern edge as they appeared to have been painted and this is now coming off.

Flagpole - is in good order

Entrance Bollards – The 3 one from the left facing the memorial is loose and <u>needs to be re secured</u> **Block paving** – Paving is uneven and lifting in three areas of the main site (listed below 7 pics) and sinking in one area. The slope leading down to the seating area next to the river has lifting blocks at the transition point. This has been previously noted but will only deteriorate if not addressed.

River seating area banking- the concreate buttress at the river confluence is coming apart. Whilst this does not present a H&S issue it would be better to address it at the same time the paving is sorted.



Suggestion – consider low impact lighting for the memorial when the paving is fixed one light should be sufficient (casting onto the memorial) Alternatively, tree up lighting.

Bullpit Lane War memorial

Overall apperance – The memorial looks quite forlorn/ sad and forgotten. It is placed in such a way that it blocks access to the playing fields and gives the impression that a hole was made in a boundry hedge of the tree line walkway and is not an official access point.

The area directly surrounding the memorial -is largely uneven despite attempts to level it with pavers. Roots from surrounding trees are exposed and present a trip / slip hazard.

Memorial – it appears to be a stopping area for dogs to cock their legs prior to entering the playing field area and as such is disrespectful.

Trees – The trees either side of the memorial both shade it (promoting alge) and do not make best use of light for the walkway. I suggest that the site would benefit from removal of the lower branches to lift the canopy and allow light into the area.

Suggestions – The memorial could be moved to small garden area outside the LH gated entrance to the football club.

Alternatiely the path should be split to go around the memorial with the low level heging cut back 6ft either side directing people to go around it at a slight distance. (avoiding the opportunity for dogs!)
