

## EP2023030 Approval of Minutes of the Meeting held on 18<sup>th</sup> May 2023 and update on actions.

#### EP2023031 Planning applications:

## a) 23/01032/CERTP

Norgate House Tealgate – Sir Peter Birkett

Change of Use of existing Office building (use Class E) to a state-funded school (use class F1(a)) on a temporary basis of two academic years.

There was discussion amongst the committee regarding the educational needs of the proposed attendees, safety during the school run, traffic in and around the site and playground facilities. Would the footways be adequate, what is the typical speed of the traffic on and off the site? What about trade collecting up supplies from the trading estate throughout the day, lorries and cars parked along Charnham Park, what is the speed restriction? Councillors were also interested to know where the proposed state funded school had originated from, who is deemed as the



competition? Information on the application was deemed to be severely lacking and it would benefit from a proper planning analysis.

Resolution:	Objection based on the lack of information on highway safety, the educational needs of the school pupils, workforce (ie teachers and number of employees), playground facilities, sustainability of the location, parking accessibility and change of use from a designated employment land. One abstention.

## b) 23/01082/HOUSE

35 Charnham Street – Mrs L Summers

Alterations to rear aspect to introduce wider door opening, replace external windows with metal doors and replace sash windows with UPVC Sash windows with internal alterations. Committee discussed the conservation area and whether there were any constraints or restrictions around the use of UPVC vs wooden framed windows at the front and rear of properties. The Councillors felt there is a need for WBC to provide a policy around the use of more sustainable materials in conservation areas for town councils to follow.

**Resolution**: Objection due to the use of UPVC windows being used in a conservation area. Two abstentions, one no objection. Majority ruled.

125 High Street - Ravensford Estates Ltd

Application to determine if prior approval is required for a proposed: Prior Notification requirement under Part G of the GPDO for the change of use of the upper two floors from ancillary retail space (Class E) to form 2 apartments. Discussions were held amongst the committee around the number of parking spaces required vs potential number of occupants, the proposed layout for the property and impact on the retail space below. What facilities would still be accessible for the employees in the pharmacy below, what about the security of the pharmacy what impact would the property have on this valuable retail unit in the High Street?
